

**KING AND QUEEN COUNTY TAXES DUE DECEMBER 5, 2020  
REAL ESTATE TAXES**

**Tax Payments:** This year you can pay your taxes several ways: (1) mail; (2) at one of the banks listed below; (3) credit card over the phone; (4) credit card over the internet, and (5) using the drop box listed below. Avoid standing in line by using one of the above options!

**TO PAY TAXES AT THE BANK:**

Taxes may be paid for the exact amount printed on the enclosed bill at the bank. The following locations have agreed to collect taxes for King and Queen County for the 2020 year:

Bank of Essex - Manquin, Tappahannock, and West Point  
C & F - West Point (Main Office & 14th Street), Middlesex and Mechanicsville  
(C & F has New Hours of Operation effective Oct 5, 2020.)

No tax bill will be accepted after December 5, 2020 at any bank. You must present the bottom portion of your tax bill when paying at any bank. After December 5, 2020 taxes must be paid at the Treasurer's Office or mailed with a December 5, 2020 postmark.

**TO PAY TAXES BY MAIL:**

Mail your taxes by the due date in the enclosed envelope. So that taxes can be posted correctly to your account, you must mail the bottom stub from your tax bill for each account you wish to pay. The official U.S. postmark will be used as the posting date. Please send self-addressed stamped envelope if a receipt is desired.

**TO PAY TAXES BY CREDIT CARD OVER THE PHONE:** (Visa, MasterCard, American Express or Discover) Dial 1-800-272-9829 from any touch-tone phone. Information you will be asked to supply: (1) jurisdiction code for King and Queen County which is **6221**; (2) Map ID number from the enclosed tax bill; (3) valid credit card number and (4) daytime telephone number. A handling charge will be added to each credit card payment.

**TO PAY TAXES BY CREDIT CARD OVER THE INTERNET:** (Visa, MasterCard, American Express or Discover) Go to website **www.officialpayments.com** to begin the process. Information you will be asked to supply (1) jurisdiction code for King and Queen County which is **6221**; (2) Map ID number from the enclosed tax bill (3) valid credit card number and (4) daytime telephone number. A handling charge will be added to each credit card payment.

**LOCKED DROP BOX:** As you enter the building, at the entrance to the Sheriff's Office is a ***locked drop box***. You have the ability to enter the building and use the drop box 24 hours a day - seven days a week to pay taxes! See instructions on full page insert included in this bill.

**COLLECTIONS:** Failure to pay this bill by the due date can cause a delay in any state income refund and/or invoke collections procedures per the Code of Virginia.

**Real Estate Tax Relief**

If you are at least sixty-five years of age or permanently and totally disabled, you may qualify for Tax Relief. Very specific criteria must be met, including residing on the property and an income level that cannot be exceeded. You must apply for tax relief by April 1 each year.
